

# Application form for the *Delft Blue Scholarship* for the Research Master in Water and Sustainable Development Programme 2026/2028

I apply for the ***Delft Blue Scholarship*** offered by IHE Delft Institute for Water Education, and I confirm that:

- 1) I do **not** have sufficient financial means to cover the **full costs** of the MSc study.
- 2) I have received confirmation of academic admission to the Research MSc Programme in Water and Sustainable Development 2026/2028.
- 3) I am aware that the ***Delft Blue Scholarship*** offers a 35% reduction on the tuition fee, before VAT, of the Research MSc Programme in Water and Sustainable Development 2026/2028.
- 4) I can cover the remaining costs of the Programme by private means. Other sponsors are not eligible for this scholarship.
- 5) I am aware that the remaining costs are:
  - Tuition fee € 23,725 (excluding 21% VAT)
  - Insurance € 1,283 (subject to price increase)
  - Visa € 243 (subject to price increase)
  - Living and accommodation costs for 22.5 months stay in the Netherlands €27,450 (estimate)
  - Personal allowance (settling in € 300 (estimate))
  - Return ticket from and to my home country
  - Research related fieldwork cost
- 6) In addition to the completed scholarship application form, I am providing a bank statement, in my name, to prove that I can cover all the costs mentioned under item 5.
- 7) If I am selected I am able to pay to IHE Delft the tuition fee including VAT, plus insurance and visa costs within two weeks after receipt of the invoice.
- 8) If I have been or will be awarded another scholarship that covers the full or partial costs of the MSc Programme, IHE Delft has the right to withdraw the Delft Blue Scholarship.

## **Important:**

Although only the study costs minus 35% of the tuition fee need to be paid to IHE Delft, we also need proof that you can cover the costs of living and accommodation for the full duration of the study.

## **Needed proof of funding:**

A bank statement in your name (not from a savings or investment account) showing that the following amount is available: Tuition fee € 28,707 (including 21% VAT); insurance € 1,283; visa € 243; living and accommodation costs € 27,450; personal allowance € 300; adding up to a total amount of **€ 57,983**.

**Scholarships are allocated on first come, first serve basis**

\* Note that before we can apply for your residence permit we have to proof to the IND that you can cover the cost of living and accommodation for the full duration of the study. By then we might again will need confirmation showing that the amount of €27,450 is freely available otherwise the IND will not grant you the residence permit.
